# The Community Achievement Awards for Regional NSW and the ACT have been launched for 2021 and the state-wide search has begun.

Our local Community College has been nominated under the category of 'Australia Connecting Communities Award' for the work they do, not only in Barraba but across the region in all the towns they offer a service.

Alison Heagney the College Executive officer said "Our community support often takes creative forms, for example, with the closure of our local newspaper, the College is supporting a social enterprise initiative of the Barraba Community News, run by volunteers. In Inverell we recently donated an old campus for the new Women's Cottage, a meeting place for women. The College also facilitates RAMHP a programme for mental health first aid, which teaches adults how to recognise the signs of mental health and how to provide the initial support to other adults, who are developing a mental illness and experiencing a mental health crisis."

The Community Achievement Awards started in 2002 as the NSW/ACT Regional Achievement and Community Awards, with the purpose of encouraging, acknowledging, and rewarding the valuable contributions individuals, communities and businesses are making throughout regional New South Wales and the ACT. The Awards create the opportunity to recognise their hard work and dedication and their contribution to the future of regional New South Wales.

The Australia Connecting Communities Award recognises grass-roots, 'real life' initiatives (led by local community groups or notfor-profits) that demonstrate genuine involvement, long-term value and add to the life of their community.

These initiatives may meet a specific need or simply be a 'fun' way to celebrate being part of a community. These initiatives foster a strong sense of community spirit, which plays a vital role in enhancing the way people connect in their community.

Our local Community College serves its communities whole-heartedly by providing meaningful and valuable life and job skills, in communities where it is much needed. Employment skills are a key driver of regional economic prosperity, with flow-on effects for the overall social wellbeing of residents.

Alison went on to say "We adapt to current and long-term situations in our rural and remote communities and planning for economic diversification. For example, during the drought we began providing subsidised courses for local farmers and small businesses to stimulate learning and community involvement during a challenging time. Another example is that the College is a Network partner to Be Connected, which brings together community members, old and young to strengthen digital literacy."

# **Snapshot of NSW COVID-19 assistance**

On 13 July 2021, the NSW and Federal Governments announced their economic support package aimed at supporting businesses and residents to deal with the recent COVID-19 lockdown.

Outlined below is a snapshot of the key economic support measures being offered to those dealing with the economic ramifications of the health and safety requirements currently being experienced by the community. Please refer to the relevant administering body for the specific eligibility criteria and application process as applicable.

Businesses can register their interest in the key business support measures that are administered by Service NSW here.

Economic support measure	Summary of Government assistance
NSW 2021 business grant Administered by Service NSW at <u>service.nsw.gov.au</u> with registrations open from 19 July 2021.	Eligible NSW businesses (including sole traders and not-for- profit organisations) with Australian wages below \$10 million can claim grants between \$7,500 and \$15,000 as a result of the COVID-19 restrictions. Three different grant amounts will be available depending on the decline in turnover experienced during the restrictions, being:
The Federal Government has indicated that these payments will not be taxable.	<ul> <li>\$7,500 for a decline of 30% or more;</li> <li>\$10,500 for a decline of 50% or more; or</li> <li>\$15,000 for a decline of 70% or more.</li> </ul>
Saving Jobs – NSW small and medium business support payments Administered by Service NSW at <u>service.nsw.gov.au</u> The Federal Government has indicated that these payments will not be taxable.	<ul> <li>Eligible NSW businesses with an annual turnover of between \$75,000 and \$50 million that can demonstrate a 30% reduction in turnover (compared to an equivalent two week period in 2019) will be entitled to business support payments from week four of the lockdown.</li> <li>Eligible entities will receive 40% of their NSW payroll payments, at a minimum of \$1,500 and a maximum of \$10,000 per week.</li> <li>Assistance will cease when the current lockdown restrictions are eased, or when the Commonwealth hotspot declaration is removed.</li> <li>To receive the payment, entities will be required to maintain their full time, part time and long-term casual staffing level as of 13 July 2021.</li> <li>For non-employing businesses (e.g., eligible sole traders) the payment will be set at \$1,000 per week.</li> </ul>
Micro business grants Administered by Service NSW at <u>service.nsw.gov.au</u> The Federal Government has indicated that these payments may not be taxable.	Eligible 'micro businesses' (including sole traders) with a tumover of between \$30,000 and \$75,000 that have experienced a decline in turnover of at least 30% will be eligible for payments of \$1,500 per fortnight of restrictions from late July 2021.



## History Notes

After some "chopping and changing" the markets did go ahead in the IGA hall and

it was the right decision in the end, due to the cold wind and the muddy museum grounds. Good decision Jenny.

The Woodsreef race track has raised some interest and it seems that it was out in the vicinity of the Nangarah gate. The big wooden gate has long gone and been replaced by a modern ramp but we would still like to find out more about its exact site – was it up the hill from the gate?

This week we have been faced with another problem. A collection of Busby photos has arrived in town, mostly without names on the back and apart from a few well known family members, identification has been difficult.

There is a photo titled "Souvenir of Our Trip to Jenolan Caves" in the collection and it has been reproduced in The Barraba News for everyone to enjoy. The Jenolan Caves was a popular spot for Barraba couples to honeymoon in past years and Julie has used her Busby/Williams connections to do some research.



Well know townsman, C.G. Williams, lived at Roxton with his wife, Emily, for many years. They raised six children - sons Gordon, Geoff and Guy who grew to become landowners in the district and three daughters - Dulcie, May and Nellie. The Williams and Spencer boys played a lot of tennis and travelled to tournaments in other towns and then players from across NSW came to Barraba tournaments. Some Barraba players also had success in Sydney at Country week. We knew that May Williams married Dick Busby so Julie set to work to find out the exact date - 22nd March, 1922 and the only clue we had was "sat 1/4/2" on the back of the photo. It turned out that the 1st April, 1922 was a Saturday and thus the Busbys could have gone to Katoomba for their honeymoon. A search on the internet turned up an almost identical photo of another group outside Hartley Court House in 1922 described as "Hector Benassai's Cadillac Service to the Caves". So the photo is probably taken in the caves area and May and Dick Busby would be in the car although we have not identified them as yet.

Now to the make of the car. Lots of ideas were also aired on the internet it seems that the most likely it is a Hudson Super Six 7 seater from around this 1918 – 20 period. The hubcaps look to be Hudson.

This example proves that some photos can be identified so long as we are prepared to put some work into it. Perhaps there are other examples around that could be identified – the society has a homestead and a group of women somewhere in the collection which need to be identified!

## National Firearms Amnesty

If you have an unregistered or unwanted firearm, this is an opportunity to hand it in without penalty.

In New South Wales, you can surrender your firearm at your nearest police station or participating licensed firearm dealer.

Please do not turn up unexpectedly with a firearm. Contact the police station or dealership in advance to arrange a drop off time.

Contact your nearest police station or licensed firearm dealer (only available in some states) prior to surrendering your firearm, firearm part or ammunition.

When surrendering a firearm, make sure the firearm is unloaded and where possible, remove the bolt or other method to render the firearm safe.

Your firearm should be placed in a gun bag or be wrapped in a blanket prior to taking it to a participating licensed dealer or to a police station.

Ammunition can be taken to a participating licensed dealer or to a police station at the same time as your firearm but should be in a separate bag, box or container.

The Amnesty indemnifies anyone from prosecution who is surrendering an unlawful possession of a firearm, firearm parts and ammunition. FACT: The amnesty does not protect people found in possession of an unregistered firearm. www.crimestoppers.com.au/firearmamnesty/nsw

### **National Lamington Day**

Every year on July 21st, National Lamington Day celebrates Australia's most famous culinary icon, the Aussie Lamington.

The day also encourages people to eat a Lamington while spreading the word about this tasty cake.

So, what is this delicious treat? It is essentially an Australian cake that is made from squares of sponge cake or butter caked, which is then coated in a layer of chocolate sauce, and finally rolled in desiccated coconut.

#### Is your mouth watering yet?

The thin mixture is absorbed into the sponge cake's outside layer, and it is then left to set. This creates the distinctive texture of the cake. There have been a number of different variations of this cake that have been created over the years.

#### Where did it all begin?

This Australian cake was first invented in Queensland, with a recipe appearing in the Queensland Country Life newspaper in 1900.

One account suggests that the Lamington was first served in Toowoomba, when Lord Lamington (Governor of Queensland) took his entourage to Harlaxton House to escape the steamy heat of Brisbane whereas another claims that it was created by Chef Armand Galland at Queensland's Government House in Brisbane during the busy period leading up to Federation in 1901. A further alternative claim is that Lord Lamington's cook, presumably Galland, accidentally dropped a block of sponge cake into a dish of chocolate. It was later discovered that desiccated coconut, sprinkled over the top, made the cakes more appealing.

The first known mention of "Lamington cake" appears in an 1896 newspaper account of a "Lamington Function" at Laidley in Queensland. The event was in honour of Lord Lamington (although it appears he did not attend) and also featured "Lamington Tea", "Lamington Soup" etc, so, in the absence of any description of the cake, the name of the cake might signify nothing more than the name of the event.

A 1900 recipe for Lamington Cakes has been found in the Queensland Country Life newspaper.

While the recipe originated in Queensland, it spread quickly, appearing in a Sydney newspaper in 1901 and a New Zealand newspaper in 1902.





Let's bake - easy homemade Lamingtons

**YIELD** makes 12 lamingtons INGREDIENTS Sponge cake 70 grams (1/2 cup) plain flour or all purpose flour 35 grams (1/4 cup) cornflour or cornstarch 1/2 teaspoon baking powder 3 large eggs, room temperature 50 grams (1/4 cup) caster sugar 2 tablespoons milk 1 tablespoon butter Chocolate icing 40 grams (1/2 cup) cocoa powder 250 grams (2 cups) icing or powdered sugar 2 tablespoons unsalted butter, melted

120 ml (1/2 cup) milk 120 grams (2 cups) shredded coconut

#### INSTRUCTIONS

Preheat oven to 180 C (350 F) standard / 160 C (320 F) fan-forced. Grease and line an 8 inch baking square tin with baking paper. Lightly grease the inside of the paper with a little butter as well.

Sift flour, cornflour and baking powder twice into a large mixing bowl. Set aside.

In a separate mixing bowl, add eggs and start to beat using an electric whisk. Once the eggs start to go thick and foamy, add sugar, one tablespoon at a time.

Continue to beat the eggs until they are thick and voluminous – this can take 5-8 minutes. You'll know the eggs are ready, when you can draw the number 8 on top and it stays for 1-2 seconds.

Meanwhile, add milk and butter to a small microwave-safe bowl and heat for 30 seconds or until butter is melted. Leave to cool slightly.

When the eggs are ready, gently add the sifted flour mixture, pour butter mixture down the side of the bowl and gently fold until flour is JUST combined. Do not over mix or you'll mix all the air out of the eggs.

Add mixture to prepared cake tin. Bake for 20-23 minutes or until cake gently springs back when lightly touched on top. Leave to cool completely.

To make the chocolate icing, sift cocoa powder and icing sugar. Add melted butter and milk and stir until chocolate is smooth.

Cut sponge cake into 12 squares. Carefully and quickly dip each piece of cake into chocolate, let the extra chocolate dip off and then cover in coconut. Transfer to a cake rack to dry.

Repeat with remaining cake squares.
