

# Nandewar Historical Society Inc

### History Notes

Well, show weekend is over and it certainly looks to have been successful in spite of Tamworth trying to steal our space. The Show has had its spot at this time of year for most of its 120 year history, while the Tamworth show was always the week before the Sydney Royal Show began. In the days before big trucks and sealed roads the Show Cattle travelled to Sydney by train from the Tamworth Show and incidentally returned by train to Barraba about two weeks later.

This week I have been trying to sort out several family history documents all stored in one album - letters, family trees, and of course, attempts to write the history of one family on one page - a very time consuming problem which needs to be done now that we have filing cabinets. Hopefully finding these families will soon be easier. The shelves have been reorganized and all the boxes are being labeled so finding someone's family tree should be a lot easier. The clean-up has found the tablecloths for the market stall with the exception of the big damask one which walked away some time ago!

The markets are on this weekend so come along and have a chat, inspect the stalls and have a cup of coffee. There will be two lots of plants as well as the usual goods for sale. Read the advertisement for more info.

Members, the meeting this month has to be postponed to the 4<sup>th</sup> Tuesday due to lack of numbers available-too many appointments and holidays!

The talking continues about the opening the town clock in 1924- still no sign of the paper clipping which I am sure exists. Some people suggest that the clock was opened on Anzac Day but the post card that my grandmother had, was, I thought dated November, 1924. There is no plaque anywhere on the clock as Trixie Garland searched everywhere around the clock and failed to find anything. The plaque recently placed in the garden outside The Playhouse is the only record of the opening of the clock and I am not sure of its origin.

Checking through the miscellaneous file I have come across the list of rules for shop assistants in 1854. I am sure we have shared the rules for teachers in 1872 but this is on another level! More next week.

# CONSTRUCTION BEGINS ON NEW MENTAL HEALTH UNIT

Construction on a new Mental Health Unit for Tamworth will begin in just a few short weeks with fencing, bunting and scaffolding now on site at the Tamworth Hospital. Member for Tamworth Kevin Anderson has welcomed the arrival of workers on site who will begin preparing the site for construction.

"Building a new mental health unit for Tamworth has been at the top of the priority list, and it's great to see that work is about to begin on the facility that we so desperately need," Mr Anderson said. "This will be a world class facility that includes 37 beds, including those for children and adolescents and for seniors which means every part of our community will have access to acute mental health services when they need them. This is so important for children and adolescents who will be able to access help closer to home and ends the practice of sending kids to Newcastle's NEXUS facility. The facility will provide welcoming, comfortable, safe and supportive facilities, while also expanding the services available in our area, meaning more people will be able to access help closer to home. Congratulations to the Tamworth Mental Health Carers Support Group who have been instrumental in the campaign to build a better Banksia. Their advice and advocacy have been invaluable."

Construction on the multi-million dollar facility is expected to take 18 months to complete and is expected to be open in 2025. # Proposed New Veterans' reforms: Government confirms it will add a year long delay

- Labor announces year long delay for veteran's reforms with start date pushed back from 2025 to 2026
- Labor's draft Bill threatens to create four categories of veterans' entitlements instead of one
- Labor's draft new laws already 2 months overdue from Royal Commission's deadline.

Despite the very first recommendation of the Royal Commission into Defence and Veteran Suicide stipulating that reforms to veterans' entitlements should commence "no later than 1 July 2025", the Federal Labor Government has today confirmed it will drag the timeframe out for another year to 1 July 2026. Former Deputy Prime Minister and Shadow Minister for Veterans' Affairs, Hon. Barnaby Joyce MP, also warned today's release of draft reforms risked creating four categories of veterans' entitlements, when the purpose of the reforms was to consolidate entitlements into one streamlined and harmonised process.

"The Royal Commission made it clear that the new draft Veterans' Entitlements, Treatment and (Simplification and Harmonisation) Bill should have been ready for consultation on 22 December last year. The government failed, and it has been released today more than two months late," Mr Joyce said. He said the first recommendation also stipulated that if the new laws were passed by Parliament then the "Government should ensure that, by no later than 1 July 2025, the new legislation has fully commenced and is fully operational. Today we find the Labor Government won't deliver on that timeframe either. Instead, the Minister has announced a further year long delay saying "it is proposed that the new model for veterans' compensation commences on 1 July 2026. That's one year later than the very first recommendation of the Royal Commission. If Labor can't deliver on the first recommendation, what hope is there of Labor delivering on the others?" Mr Joyce asked.


He said the delays were a direct result of Prime Minister Albanese's decision to dump the Minister for Veterans' Affairs from Cabinet. "One would presume that the Ministers lack of ability to get this on to the legislative agenda is because he is not in Cabinet. When a Minister is not in Cabinet their legislation goes to the back of the

queue," he said. Mr Joyce said the discussion paper attached to the draft new laws included many wishy-washy phrases such as veterans would be "potentially eligible for increased" payments or that they "may now become eligible" for entitlements. "They're not the sort of words that indicate clear, concise and simplified criteria," he said. "When people enlist they don't say to themselves 'I may be required to go overseas but I will only consider that order'. The same people who are now veterans, are probably not very tolerant of words that mean nothing when it comes to concrete delivery of outcomes," he said.

Mr Joyce said veterans' entitlements had become a confusing mess over the decades with entitlements and compensation often determined by different rates and on different eligibility criteria. The three Acts are the Military Rehabilitation and Compensation Act 2004 (MRCA); the Rehabilitation and Compensation (Defence Related Claims) Act 1988 (DRCA); and the Veterans' Entitlements Act 1986 (VEA).

"While the Coalition welcomes the government's proposals to harmonise and improve some of those entitlements, for example in areas such as funeral allowances and improved disablement entitlements, the government is not proposing to harmonise all entitlements across the three Acts. It is simply cherry-picking what will be harmonised," he said. "We will have veterans covered by the old MRCA; and then veterans covered by the old DRCA; and then veterans covered by the old VEA; and then a new category of veterans covered by the new MRCA. That's not a simplified and harmonised outcome. When you combine three Acts you should be able to not differentiate between the benefits. Otherwise, you will merely get the previous three Acts with one new name."

Mr Joyce said submissions on the draft new laws would close in late April and urged veteran organisations to insist the government sticks to the Royal Commission's timeframes.





# Council meeting update Here is an overview of outcomes from Tamworth Regional Council's Ordinary Meeting Tuesday 27 February, 2024.

As the first step of the broader comprehensive review of the *Tamworth Regional Local Environmental Plan 2010 (TRLEP 2010),* Councillors have supported a recommendation for a planning proposal to be prepared and submitted next month to the Department of Planning, Housing and Infrastructure requesting a Gateway Determination. A 36-page report tabled at the meeting revealed Council's review of the TRLEP 2010 is a direct action out of the Tamworth Regional Blueprint 100 strategy and will be undertaken in phases. The report said that as part of the first phase review of the TRLEP 2010, planning studies have been completed along with property owner engagement and an EOI process inviting property owners to identify potential changes to the TRLEP 2010. The first phase review will include:

- Heritage Items including the addition of King George V
   Avenue Memorial English Oaks and the Manilla railway underbridge at Upper Manilla over Borah Creek;
- Creation of new Heritage Conservation Areas including a new Darling Street Civic Precinct;
- Changes to the floor space ratio and subdivision provisions and applying design excellence controls for properties in the Bridge Street Precinct which aim to encourage urban renewal in the area;
- Review of land use permissibility within existing land use
- Amendment to existing clauses and proposed new clauses;
- Adoption of eco-tourism and dwellings affected by natural disaster clauses;
- o Expressions of Interest; and
- Housekeeping such as mapping anomalies.

It is anticipated the public exhibition will take place in June 2024, subject to the conditions of the Gateway Determination.

To offer greater support and flexibility to customers with changing and difficult circumstances, Councillors adopted updates to a number of financial policies. The draft Pensioner Policy, Debt Recovery Policy and Hardship Policy were placed on public exhibition for a period of 28 days from 13 December. The updated policies will come into effect immediately.

Safety and improved access for locals lead 14 recommendations made by the Tamworth Local Traffic Committee when they met in early February. Councillors considered and agreed with the committee's recommendations including improvements to be made to improve traffic visibility and safety at Timbumburi School through new Give Way signs, painted median and associated line marking on both Kia Ora Lane approaches with the New England Highway, Timbumburi. To support access to local business, changes to parking on Darling Street in Tamworth were also approved. Two, 15-minute parking spaces will replace an all-day parking zone outside of Fords Butchery on Darling Street, to provide customer parking options on the busy corner.

Another bronze statue could be coming to Tamworth, this time recognising musician Roger Knox and his contribution to the Tamworth Country Music Festival. Councillors supported a move by the Tamworth Region Arts Advisory Committee and Tamworth Region Inclusive Culture Advisory Committee to recognise the Gomeroi song man through art. It is proposed the new statue would be installed in Peel Street alongside other greats of the industry including Slim Dusty and Joy McKean, Smokey Dawson and John Williamson and is dependent on external fundraising.

# IPART seeks feedback on Special Variation application

Today the Independent Pricing and Regulatory Tribunal (IPART) has opened its public consultation about applications from Tamworth Regional Council and eight others across NSW which are seeking a Special Rate Variation.

All applications are published on the IPART website <a href="www.ipart.nsw.gov.au">www.ipart.nsw.gov.au</a> along with information about how it assesses applications. There is a five-minute survey to provide feedback. The IPART consultation is open for 20 days. Decisions about applications are expected to be published on the IPART website by May 2024. Council lodged an application earlier this month for a permanent Special Rate Variation of 36.3% over two years. The application comprises a variation of 18.5 per cent from July 1, 2024-25 (including the set rate peg of 4.9%) and 15% in 2025-26 (including the forecast 2.5% rate peg). # Teeing off in Tamworth: Senior Amateur set for country music capital



Defending Champions Nadene Gole and Andrew Tharle will compete in the 2024 NSW Senior Amateur at Tamworth and Longyard Golf Clubs next week

Reigning NSW Senior Amateur Champions Andrew Tharle of Royal Canberra and Nadene Gole of Victoria will defend their crowns when the 2024 NSW Men's and Women's Senior Amateur Golf Championships begin at Tamworth and Longyard Golf Clubs next week.

Tharle and Gole headline a 270-strong field of competitors that boasts several state and national champions at Senior and Mid-Amateur levels; Monash County Club's Jacqui Morgan, a seven-time winner of this event, Port Macquarie's David Bagust (winner in 2020 and 2022), and three-time Australian Senior Amateur champ Sue Wooster from Victoria (2018, 2019 and 2022).

Locals hoping to add the NSW Senior Amateur crown to their resume include local David Hamilton, the current Tamworth club champion who plays off a formidable plus three handicap, former PGA member Anthony Painter, and Longyard's Matthew Thomas, who will be in the mix.

The week will kick off with the 18-hole Men's and Women's NSW Foursomes on Monday, March 4th, with 54-hole NSW Senior Championships starting Tuesday, March 5th and running until Thursday, March 7th.

The final round on Thursday at Tamworth Golf Club will be a seeded affair, with the leaders expected to tee off at around 12.30 pm.

Golf NSW is thrilled to partner with Tamworth Regional Council to bring the time-honoured Championships to the city, with competitors from across the continent descending on Australia's country music capital for the four-day event.

Tamworth Region Mayor Russell Webb said the tournament, the first of three major Golf NSW Championships heading to the area, was a win for the local economy.

"I'm very excited to welcome Golf NSW and their competitors to our region for this multi-day event. This three-year sponsorship agreement, until 2026, will be a substantial boost to our city's economy, benefiting both local businesses and tourism. It will also put Tamworth firmly on the map for golf enthusiasts and visitors alike".

Golf NSW Chief Operating Officer Mr Graeme Phillipson said the Senior Amateur Championships always attracted a strong field, and this year's field of almost 270 players will be a massive boost for the local economy.

"With COVID now firmly in the community's rear-view mirror, participant numbers are at their highest for several years.

The NSW Senior Amateur Championship is the highlight of the golfing year for those over 50, and combining the men's and women's titles into one event will be a boon for the region.

The interest we receive for this event is growing. We have competitors from every state in Australia, and come Thursday, I'm sure we will have two very worthy champions," he added.
















# Engaging with IPART about special variation applications for 2024-25

23 October 2023

IPART assesses special variations (SV) applications made by councils. We assess SV applications against criteria set by the NSW Office of Local Government (OLG) (see below). Your submission can help us better understand whether a council's application meets OLG's criteria.

This fact sheet can help you better understand what we can and cannot consider as part of our assessment. This will help your submission to be more effective.

## 1 What is a special variation?

Each year, we set the percentage amount each council may increase its general income for a financial year. This is called the rate peg. For most councils, general income is the total income the council receives from ordinary and some (but not all) special rates.

If elected councillors resolve that a council needs more income, a council can apply to IPART for an SV to increase its general income by more than the rate peg.

### 1.1 How do we assess a special variation application?

We assess councils' applications against the OLG's criteria. These are set out in OLG's guidelines here.

The OLG criteria require councils to:

- · demonstrate the need for the additional income
- provide evidence that the community is aware of the need for and extent of a rate rise
- establish that the impact on affected ratepayers is reasonable
- exhibit, approve and adopt relevant planning documents
- explain and quantify the council's productivity improvements and cost containment strategies.

We may also consider anything else we consider relevant.

### 4.3 Misconception: If the community doesn't support the SV, it can't be approved

In the past, ratepayers have written to us noting that the lack of community support for an SV should mean that an SV application should not be approved. Community support is not required for us to approve an SV application.

To demonstrate it has met the OLG criterion about community awareness, the council must show IPART that the community is **aware** of the need and extent of a proposed rate rise. Our assessment considers the <u>effectiveness</u> of the council's consultation with ratepayers, rather than whether most ratepayers support the proposed SV.

In the past, community submissions have brought to our attention deficiencies in a council's consultation materials that have contributed to council applications being declined, or approved for a lesser percentage than applied for, based on whether the community is aware of the proposed rate rise. For instance, the council may have applied for a higher increase than they informed the community about, meaning the community was likely not aware of the increase that was applied for.
