
We miss Ruby more and more every day but now live by a famous Winnie the Pooh motto of "how lucky am I to have something that makes saying goodbye so hard".



After last week's "Shop Assistants in 1854" there is another one but it can stay in the folder for the time being. The sorting and filing of the heaps of records continues as I have been trying to make sense of another early family.

The convict records usually give theft of articles such as food, clothing, money and livestock such as horses, sheep and lambs but this time I have found "shot a neighbour's rabbit" which may or may not be true but certainly attracts the attention. This fellow obviously came to Australia but I have a feeling that the reason for coming maybe fiction in this case. Anyway, he settled down in Australia with his wife, also a convict, and made a successful living. Incidentally they left a lot of descendants - families of nine or ten over at least three generations with many names used in each generation. At least we now have two of these families sorted with one large one to go - I don't know how they all came to be in the one folder but they should soon be in three folders.

I wonder how many residents remember that 2024 marks 20 years since the Council amalgamation with Tamworth. Council put out a Community Newlink pamphlet each quarter and the one that has been kept is January, 2004. The General Manager discusses Amalgamations, Barraba Water Supply, and the 2003 Citizen of the Year who was Robert Sweeney, the junior was Shaun Faulkner and Mrs. Ros. Peake received the Mayoral Award. The Anglican Ladies supplied the morning tea.

The Barraba Show was coming up with Poll Herefords the feature cattle and the poultry section returning and the wether competition was still going in those days. To top it all off Barrapella and friends - how talented they were - presenting a variety show on Valentine's Day in support of the Clifton Hall Purchase and Restoration.

Some people may remember the Waste - Art and Design Competition which was designed to use some of our waste as well as making a poster about rubbish and what we can do with it. The 2003 event was apparently very successful but I am not so sure about 2004 with everyone's eyes on the proposed amalgamation.

**Here is an overview of outcomes from  
Tamworth Regional Council Ordinary Meeting  
on Tuesday 12<sup>th</sup> March 2024:**

Councillors tonight agreed to allocate \$850,000 from the Westdale Land Reserve to provide additional funding for the Jewry Street Extension project, a heavy vehicle bypass from Taminda to the Tamworth Global Gateway Park. The money will be repaid to the reserve through the sale of land at the Tamworth Global Gateway Park. The funding for the project initially included \$5.886 million from the NSW Government’s Growing Local Economies program and \$654,000 from Council’s Civil Construction Reserve. A report to Council explained the Jewry Street Extension was completed in excess of the original \$6.54 million budget due to a range of factors. These included an 18-month delay while complex flood modelling and landowner negotiations were completed, global supply chain issues and increased material costs which could not have been forecast at the time of the funding application in 2018. The Council report said all Park land sales are returned to the Westdale Land Reserve and as at 31 December 2023 there was \$11,361,229 owing to the reserve. Currently about \$5 million of land sale revenue has been deposited into the reserve, an additional \$6.7 million of land sales are under contract and awaiting settlement and about \$9.6 million of land is available for sale, the report said.

Councillors also decided to move forward with “Australian Fauna” themed road names for Stages 12 to 17 of Moore Creek Gardens. The proposed road names are Bowerbird Road, Fantail Street, Pardalote Court, Pipit Street, Plover Street, Quail Close and Zebra Finch Drive. These names were chosen as they are birds that are identified as occurring in the Tamworth region. The proposed names will now go on display to the community and if there are no formal objections, they will be published in the Government Gazette.

Councillors agreed to a full fee waiver for the NSW Primary School Sports Association Football Championships to be held in August for the use of the Gipps Street Sporting Complex in Tamworth. The event is expected to bring 350 players to the region.

Councillors tonight considered a report showing progress on the first six months of the 2023-24 Our Annual Plan and Budget. The report – for the six months to December 2023 – revealed that from 212 reportable actions a total of 81 per cent are either complete or on track.

More than 4,000 trees were planted by Tamworth Regional Council staff and the Urban Street Tree Advisory Group in 2022 to 2023, according to a report tabled at tonight’s meeting. The report included minutes of the two most recent group meetings. It also revealed information about future tree plantings scheduled for locations such as Duri Rd, White St and Brisbane St as part of Council’s greening strategy. The report said further work to finalise a planting strategy for autumn, which includes a detailed audit of what replacement trees are needed to address the losses of plantings across the region, is underway. The plantings are funded through Council’s existing projects and operational budgets.

### **Bereen Church back to life with \$14,850 restoration complete**

The picturesque and quaint St Mark's Anglican church, nestled in the Horton Valley, has been brought back to life thanks to \$14,850 of funding to restore the 111-year-old building. I inspected the completed works alongside Gwydir Shire Mayor John Coulton and church wardens Ali and Ian McDouall last week. The restoration involved painting the exterior and interior of the building, including the roof, as well as repositioning and remounting the church. Skilled tradespeople lifted and repositioned the church onto new footings, which will assist in diverting storm water away from the foundations and maintain the building's structural integrity.



St Mark's is a much-loved church and a place of support and pastoral care for the farming families who live in the Horton Valley. It is a true local gem, absolutely adored by the local community, and everyone worked together to allow this charming old building to be so beautifully restored. The works were made possible by a \$14,850 grant under the previous State Government's *Community Building Partnership* program. A church fundraising committee was also formed, and money raised paid for a new access ramp,

minor repairs, preparation, and extra painting. Upper Horton has always been a very self-sufficient community where everyone watches out for each other, and the restoration of the church is a true reflection of this. The Bereen Church in the Horton Valley holds four services a year.

### **VALUATION NSW EXTENDS GRADUATE PROGRAM**

Exciting opportunities are being offered to launch a new career with NSW's valuation agency, Valuation NSW, offering up to seven new graduate positions in property valuation.

Valuation NSW CEO Stewart McLachlan said applications are now open for the second year of the agency's Graduate Program, creating training and job opportunities for new industry entrants.

"Valuation NSW's Graduate Program is a once in lifetime opportunity to start your valuation career with mentoring from leaders in their respective fields who are responsible for administering the state's valuation system" Mr McLachlan said. "Valuation NSW will teach you how the property sector works while building analytical skills and knowledge of valuation methodologies and market trends, to enable you to pursue a range of career paths in the industry."

Valuation NSW supports the Valuer General and is responsible for the state's valuation system, determining the value of land for rates and taxes. It keeps tabs on more than 2.6 million parcels of land in NSW valued at over \$2.80 trillion. Valuation NSW also provides independent assessments of compensation paid for land that is compulsorily acquired when landowners cannot agree on a value. In addition, Valuation NSW also provides valuation advice and services across Government including in the areas of bespoke and complex valuations and methodologies, broad brush valuation and risk mitigation strategies, as well as valuations for some of the State's key assets.

Applications for the Graduate Program are now open from Friday 15 March until Sunday 31 March, with successful applicants to be notified in April and commence in late May 2024. Valuation NSW was ranked equal first globally in 2019 by the International Property Tax Institute review of Property Tax Administration Systems.

## How do I handle it if my parent is refusing aged care? 4 things to consider


It's a shock when we realise our parents aren't managing well at home.

Perhaps the house and garden are looking more chaotic, and Mum or Dad are relying more on snacks than nutritious meals. Maybe their grooming or hygiene has declined markedly, they are socially isolated or not doing the things they used to enjoy. They may be losing weight, have had a fall, aren't managing their medications correctly, and are at risk of getting scammed.

You're worried and you want them to be safe and healthy. You've tried to talk to them about aged care but been met with swift refusal and an indignant declaration "I don't need help – everything is fine!" Now what? Here are four things to consider.

### 1. Start with more help at home

Getting help and support at home can help keep Mum or Dad well and comfortable without them needing to move. Consider drawing up a roster of family and friends visiting to help with shopping, cleaning and outings. You can also use home aged care services – or a combination of both. Government subsidised home care services provide from one to 13 hours of care a week. You can get more help if you are a veteran or are able to pay privately. You can take advantage of things like rehabilitation, fall risk-reduction programs, personal alarms, stove automatic switch-offs and other technology aimed at increasing safety.

### 2. Be prepared for multiple conversations

Getting Mum or Dad to accept paid help can be tricky. Many families often have multiple conversations around aged care before a decision is made. Ideally, the older person feels supported rather than attacked during these conversations.

Some families have a meeting, so everyone is coming together to help. In other families, certain family members or friends might be better placed to have these conversations – perhaps the daughter with the health background, or the auntie or GP who Mum trusts more to provide good advice.

Mum or Dad's main emotional support person should try to maintain their relationship. It's OK to get someone else (like the GP, the hospital or an adult child) to play "bad cop", while a different person (such as the older person's spouse, or a different adult child) plays "good cop".

### 3. Understand the options when help at home isn't enough

If you have maximised home support and it's not enough, or if the hospital won't discharge Mum or Dad without extensive supports, then you may be considering a nursing home (also known as residential aged care in Australia).

Every person has a legal right to choose where we live (unless they have lost capacity to make that decision). This means families can't put Mum or Dad into residential aged care against their will. Every person also has the right to choose to take risks. People can choose to continue to live at home, even if it means they might not get help immediately if they fall, or eat poorly. We should respect Mum or Dad's decisions, even if we disagree with them. Researchers call this "dignity of risk".

It's important to understand Mum or Dad's point of view. Listen to them. Try to figure out what they are feeling, and what they are worried might happen (which might not be rational). Try to understand what's really important to their quality of life. Is it the dog, having privacy in their safe space, seeing grandchildren and friends, or something else?

Older people are often understandably concerned about losing independence, losing control, and having strangers in their personal space. Sometimes families prioritise physical health over psychological wellbeing. But we need to consider both when considering nursing home admission. Research suggests going into a nursing home temporarily increases loneliness, risk of depression and anxiety, and sense of losing control.

Mum and Dad should be involved in the decision-making process about where they live, and when they might move. Some families start looking "just in case" as it often takes some time to find the right nursing home and there can be a

wait. After you have your top two or three choices, take Mum or Dad to visit them. If this is not possible, take pictures of the rooms, the public areas in the nursing home, the menu and the activities schedule.

We should give Mum or Dad information about their options and risks so they can make informed (and hopefully better) decisions. For instance, if they visit a nursing home and the manager says they can go on outings whenever they want, this might dispel a belief they are “locked up”. Having one or two weeks “respite” in a home may let them try it out before making the big decision about staying permanently. And if they find the place unacceptable, they can try another nursing home instead.



#### **4. Understand the options if a parent has lost capacity to make decisions**

If Mum or Dad have lost capacity to choose where they live, family may be able to make that decision in their best interests. If it’s not clear whether a person has capacity to make a particular decision, a medical practitioner can assess for that capacity.

Mum or Dad may have appointed an enduring guardian to make decisions about their health and lifestyle decisions when they are not able to. An enduring guardian can make the decision that the person should live in residential aged care, if the person no longer has the capacity to make that decision themselves. If Mum or Dad didn’t appoint an enduring guardian, and have lost capacity, then a court or tribunal can appoint that person a private guardian (usually a family member, close friend or unpaid carer). If no such person is available to act as private guardian, a public official may be appointed as public guardian.

#### **Deal with your own feelings**

Families often feel guilt and grief during the decision-making and transition process. Families need to act in the best interest of Mum or Dad, but also balance other caring responsibilities, financial priorities and their own wellbeing.

### **ACCPA Welcomes wage rises for aged care workers**

The Aged and Community Care Providers Association (ACCPA) has welcomed the Fair Work Commission decision to award further wage rises to direct care workers, but acknowledges the disappointment facing many other workers, who will receive substantially smaller increases.

The FWC awarded direct care workers wage increases of between 3% and 14%. This is on top of the 15% increase to their award rates last year. “We’re delighted the Fair Work Commission has acknowledged the vital contribution aged care workers make to our community through the care they provide to older Australians,” ACCPA CEO Tom Symondson said. “A key recommendation of the Aged Care Royal Commission was to raise the pay of aged care staff.”

Mr Symondson also acknowledged the disappointment facing thousands of other workers in aged care, who will receive rises of 3% to 7% and who also missed out on the 15% increases awarded to our care staff last year - at a time when all Australians are facing a cost of living crisis.

“There is an ever-widening chasm between what we pay some workers in aged care and what we pay others. Without our laundry staff, kitchen staff, cleaners, gardeners, maintenance, and administrative staff our direct care workers couldn’t do what they do. They all work within the unique environment of aged care whether they are delivering services to older people in their own homes or in residential care. We commend the Albanese Government for honouring its pre-election commitment and fully funding last year’s 15% award increase for direct care workers. We fully expect the Government to do the same with these increases in stage three and any further increases awarded by the Commission. As the Government acknowledged in making that promise, our sector can only afford such increases for our valued workers with matching government funding.”
